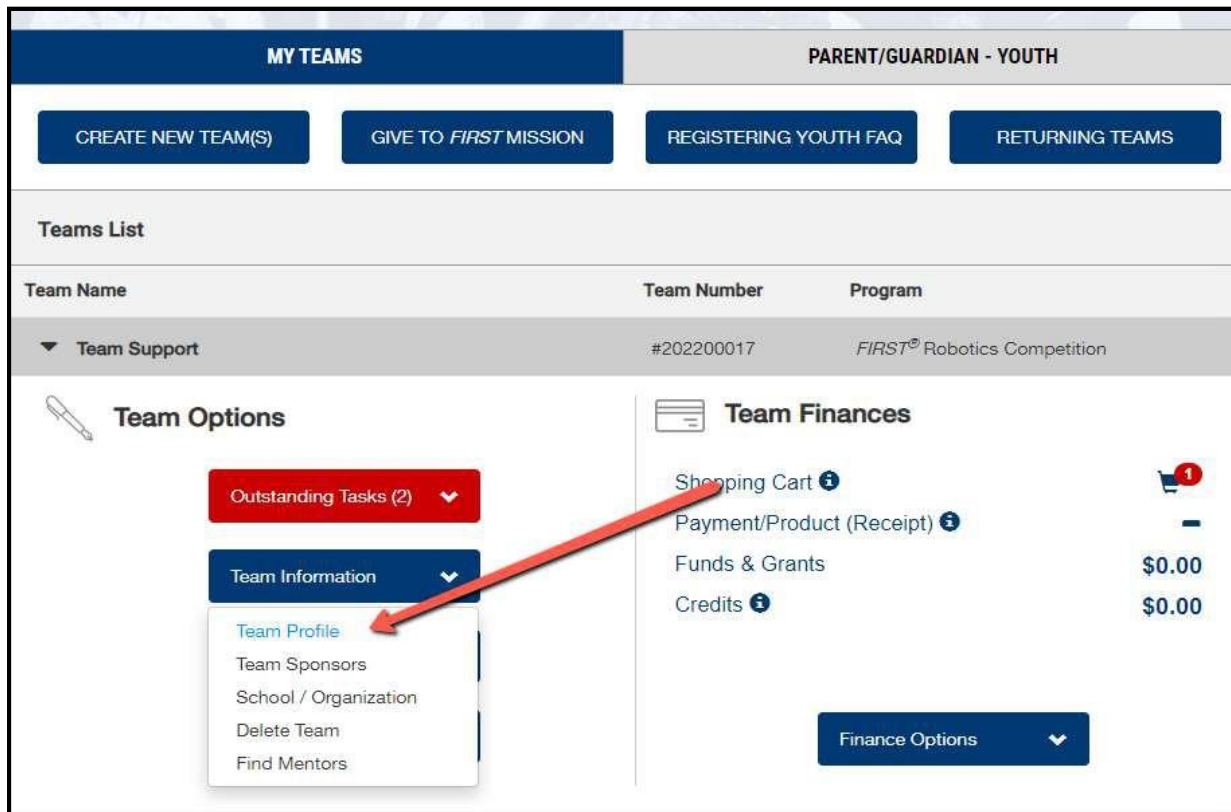


Instructions for Securing Team Registration for the 2022 Season

Lead mentors and team admins can secure team registration by following these steps:

1. Log in to the *FIRST*® account dashboard at www.firstinspires.org
2. Click the “MY TEAMS” tab
3. Click the “Team Information” drop-down in the “Team Options” column and select “Team Profile”




4. Complete the team profile information, answer the “Sales Tax Exemption Status” question, and click “SAVE”
 - If the team is located in a tax-free state (i.e., New Hampshire), select “We are required to pay Sales Tax where applicable by law” (teams located in tax-free states will not be charged sales tax on their initial registration).







10. Click “Place your Order / Make Payment”

11. Review the “Valid Sales Tax Exemption Status Pending”, check off the box to agree to the terms, and click “Continue”

- Please note: This message is shown to all teams/accounts and does not indicate your specific team’s status. If your team is tax exempt, you must upload your sales tax-exempt form and wait until it is approved before making payment.
- Tax Exempt Teams: If your team’s exempt form is approved or your team is located in a tax-free state, you may proceed with payment.
- Non-Tax-Exempt Teams: If your team is located in a state that charges sales tax and your team is non-tax exempt (i.e., community team), you can apply for a grant to cover your team’s sales tax (only available for the 2022 season) by selecting the “here” hyperlink within the “Valid Sales Tax” pop-up message.
