

Instructions for Securing Team for the 2025 Season

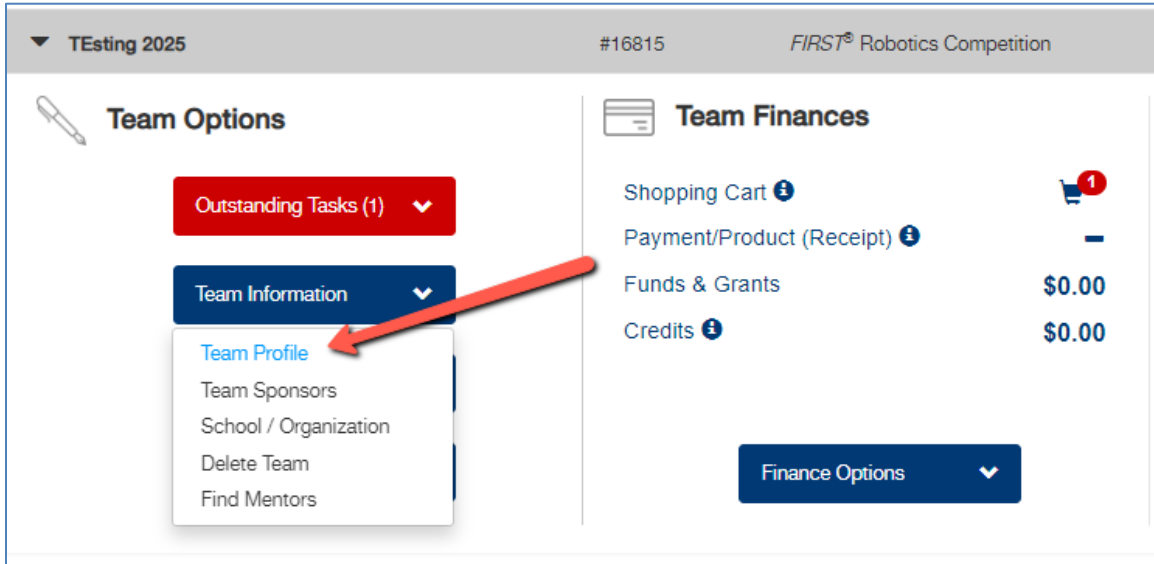
Important Reminders:

1. Payment by check: If a team secures team registration with a check, a credit will be available that the team can apply during the checkout process, and the team contacts will receive an email notification of the available credit. *FIRST* will not automatically apply the check amount to any amounts due.
2. *FIRST* Finance does not accept purchase orders sent via email, fax, or mail. Purchase orders must be uploaded during the checkout process via the *FIRST* Dashboard by a team administrator, a lead mentor 1, or a lead mentor 2.
3. ***If you are expecting a grant, please do not check out until that grant has been awarded. FIRST will not be able to make changes to orders after checkout.***

Lead mentors and team admins can secure team registration by following these steps:

1. Log in to the *FIRST*® account dashboard at www.firstinspires.org.
2. Click “MY TEAMS” tab
3. Click the “Team Information” drop-down in the “Team Options” column and select “Team Profile”



4. Complete the team profile information, answer the “Sales Tax Exemption Status” question, and click “SAVE”
 - If the team is located in a tax-free state (i.e., New Hampshire), select “This team/account does not need to upload a sales tax exemption certificate” (teams located in tax-free states will not be charged sales tax on their initial registration).

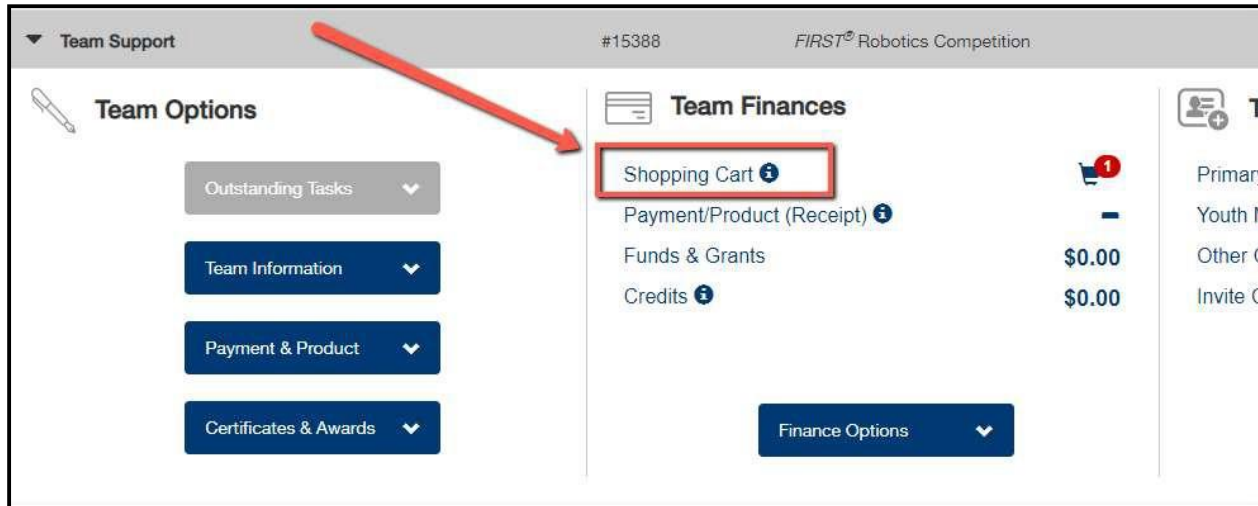

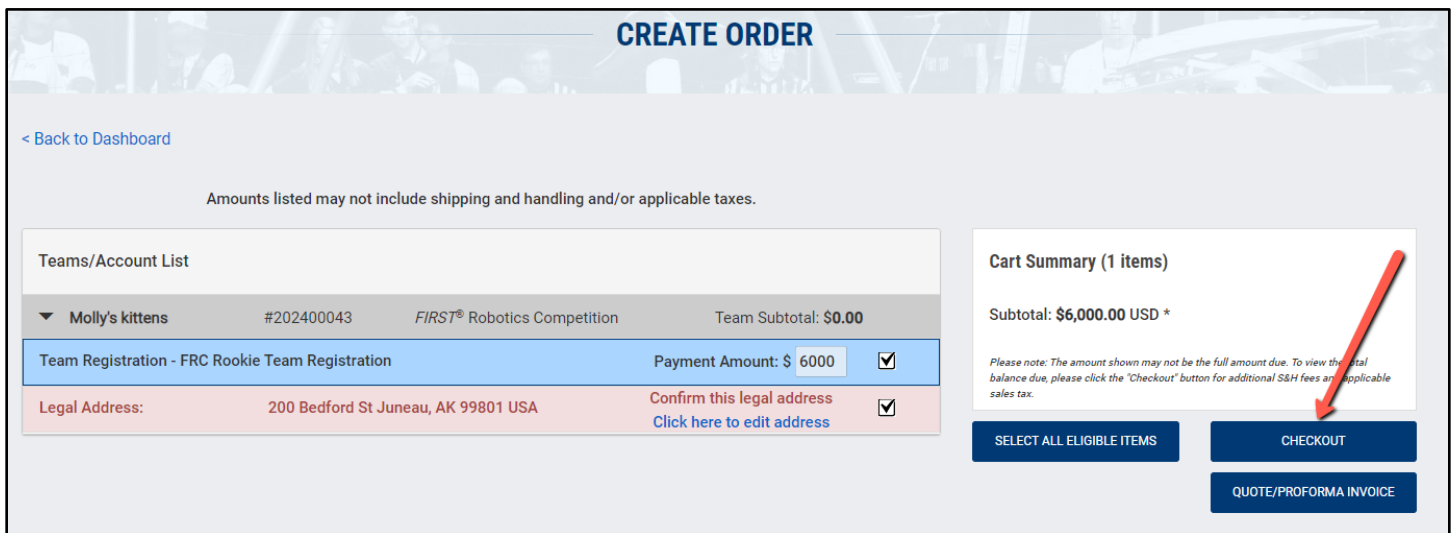

Payment Information / Acknowledgement

This notice is shown to all teams / accounts and does not indicate your sales tax exemption status. If each of your teams/accounts do not have an APPROVED certificate, appropriate sales tax will be determined by your state and assessed. Payment of taxes are NON-REFUNDABLE.

Sales tax and Tax Exemption are based on your team's "Ship to" OR "Event Address." To be exempt in that State, we need a valid fully completed exemption certificate from that State. If your state does not assess sales tax, we do not need a tax exemption form. Important information: "Name" is the exempt entity organization name. If "Seller/Vendor/Dealer" is required on the form, it MUST reflect: *FIRST*, 200 Bedford Street, Manchester, NH 03101. If required on the certificate, "Description of Sale" should be: Registration and STEM materials.
